SSVC Policy for junior riders participating in club cycling activities:

- 1) All junior riders must have a signed parental consent form, approved in advance of any activity.
- 2) There is no minimum age for junior riders on club rides. Juniors under the age of 18 can participate in a club event
- only with a Parental Consent Form that has been approved by the club in advance.
- 3) SSVC reserve the right to refuse participation or withdraw a junior rider from an event based on assessment of weather and road conditions, ar in relation to the event.
- 4) SSVC will not allow a junior rider to participate in an event that is planned to be more than 50 miles.
- 5) SSVC reserve the right to enforce a strict 18 and over participation limit for some events. This will be communicated clearly on any such events
- 6) The parent/guardian must identify a Nominated Responsible Adult to ride with the junior rider. The Nominated Responsible Adult is responsible safety and well-being of the junior rider for the duration of the event.
- 7) Parents/ guardians can identify more than one Nominated Responsible Adult on the parental consent form.
- 8) The Nominated Responsible Adult will normally be a family member or friend of the junior rider. If the parent/ guardian is unable to identify a Nc Responsible Adult, they can request that the SSVC Committee allocate a Nominated Responsible Adult from the club members to ride with the jur This will be agreed in advance of the event.
- 9) Arrangements to get to and from club rides/ events are the sole responsibility of the parent/ guardian.
- 10) DBS checks may not have been completed for the event organisers/ ride leaders/ club approved Nominated Responsible Adult.
- 11) If the are no willing club members to act as a Nominated Responsible Adult, or if the identified Nominated Responsible Adult is not able to par junior rider will not be allowed to participate in the club event, for their own safety.

SSVC, it's members and other ride participants may take photographs during group rides/ events, which may appear in the public domain.
